## **Project Updates**

>> Welcome to Troy Landscape

Landesign completed the installation on 11/21/23. Maintenance will begin spring of 2024.

>> Troy Park Maps

Student designs continue, plan to meet to approve designs in spring.

>> Kiwanis Park Disc Golf

Ryan gave a brief update on the project. 3 companies came out and put a bid. The tentative start of Jan 29<sup>th</sup> has been given. The plan is to come in and clear out ground debris prior to installing baskets.

# **Event Contributions**

>> Downtown Boutique Crawl (12/8/23) – gave \$100 from the Misc/Future Use Funds for radio advertising. Angle G. scheduled the advertising with KFAV directly. Angle Kiesey organized the event along with other local business owners and noted they saw people from outside the area.

## >> City of Troy Annual Ornaments

Discussed increasing the number of ornaments ordered for 2024. Angle G. took over the ordering/design process from the City. The cost will vary depending on the design and quantity. The board agreed to Max out the budget when ordering. If there are any ornaments left over after Night of 1,000 Stars they are to be given to downtown businesses to hand out.

>> Night of 1,000 Stars (12/2/23)

There was \$500 included in the 2023/2024 budget for this event. There was discussion and request for an invoice and/or donation receipt from The Troy Historic Downtown Business Association which was not received. A suggestion to use the funds for radio and/or social media advertising was declined. At this time, funds have not been released.

The board discussed moving the unclaimed funds to Misc. / Future Use. Ryan motioned to move funds, Angie K. seconded, and all were in favor.

>> TBHS Show Choir Invitational (2/3/24)

A \$2,000 contribution check has been provided to the Encore Choral Boosters. Fund will be used to help provide good quality judges and service which includes meals, travel, and lodging. We will follow up with Sarah (Super 8) to see how this event impacted the hotel.

# **Explore Troy App**

Chamber staff will continue to keep the app up to date.

#### **Static Billboards**

The current billboard design is good through 2/3/24. Angle G. requested input on what to promote on the next design which will run February through June. Last year the billboard promoted the Chamber's MAYB Tournament, City Wide Yard Sales, and LCCOA's Annual Fun Run.

The Chamber is not hosting MAYB in 2024. The board previously discussed and agreed not to promote runs and/or walks because there are too many similar events we can't just pick one. After further discussion, the board agreed that if suitable event was not found, Angie would put together a generic advertisement to promote tourism in Troy.

# New Discussion / Misc.

>> Shop Local Static Billboard

The CVB partnered with LCRB to begin a collaborate advertising campaign in 2014 to promote a shop local campaign, trying to reach Lincoln County residents as they are leaving Troy (located on S. Lincoln Drive in front of Store It & Go) before they head to Wentzville was the original thought. Because LCRB is funded by a ¼ cent sales tax, local shopping is critical to finance their mission and programming. The last time the board was updated it costs around \$300.

The board requested more details and updated costs to remove/install a new design. Angie will reach out to Cheri requesting additional information before the board approves funds. This item will be "ear marked" for the next meeting, gather exact numbers to verify and vote to move money from Misc Funds.
